# TERMS AND CONDITIONS OF ENTRY INTO "HCF Team Behind the Team Competition"

- 1. Information on how to enter and prize details form part of these conditions. Entry into this Promotion is deemed acceptance of these terms and conditions of entry.
- These terms and conditions of entry into "HCF Team Behind the Team Competition" ("Promotion") are authorised under ACT Permit No. TP 21/01366 and SA Permit No. T21/1245.
- The Promoter is The Hospitals Contribution Fund of Australia Limited (ABN 68 000 026 746) of Level 5, 403 George Street Sydney NSW 2000 ("Promoter"). To contact the Promoter please call 13 13 34.
- 4. The Promotion commences at 9:00am AEST on Friday 13 August 2021 and ends at 11:59pm AEST on Friday 10 September 2021 ("**Promotion Period**"). The Promoter reserves the right to extend the Promotion end date at any time (subject to regulatory approval).
- 5. Entry is only open to residents of Australia who are aged 18 years and over, have a valid telephone number and valid email address ("**Eligible Entrants**"). Where applicable all Eligible Entrants will be required to provide proof of eligibility to redeem their prize.
- 6. Employees (and their immediate family members) of HCF and agencies associated with this promotion are ineligible. An 'immediate family member' includes any of the following: spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.

Nothing in these terms and conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under the Australian Securities and Investment Commissions Act 2001 (Cth) or similar consumer protection laws in the State and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, HCF (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury, or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of this Promotion.
